#### **WELCOME**

It's that time of year again, when the **Queensland Country Credit Union Strand Night Markets** are nearly upon us for another season. Returning and new stallholders will find the application form and updated regulations on our website.

#### **REGULAR STALLHOLDERS**

In 2010 we introduced "Regular Status" to the Night Markets.

Regular stallholders will be given first option to retain their 2010 site. You will have until Friday 25<sup>th</sup> March to get your application forms back to the office. Sites not claimed after this date will be returned to the pool of available sites and reallocated. Please be aware that you will **ONLY** have first option on the same site/s you had last year. If you wish to relocate or increase your sites your application will be viewed as a new application.

Casuals who attended regularly last year will be given first option for vacant sites. If you regularly had a casual site and would like to apply for that site please advise on your application form. Whilst we cannot guarantee that we will be able to meet your request we will try our best.

Please remember that regular stallholders can only miss two Markets and still retain their regular status.

#### **POWER FOR FOOD VENDORS**

Due to ongoing issues with the power supply last year it has been decided **NOT** to provide power

this year. Therefore, all food vendors will be responsible for the supply and onsite maintenance of their own power supply. Site fees will remain the standard \$110 but there will obviously be no additional charges for power.

#### **CASHLESS AND PREPAID**

QCCU Strand Night Market will continue to be a prepaid market with all sites fees due one week before the Market date. For the 7<sup>th</sup> May Market, payments must be received by Friday 29 April. If sites fees have not been received by that date, **your booking will be cancelled** and the site will be reallocated to a casual from the waiting list.

Regular stallholders who have not paid by the due date, and have not put in a holiday form, may lose their regular status and have their site reallocated to a casual.

We will no longer be collecting prepayments on the night due to the security risk. Prepayment can be made in the following ways:
